THEME DIACONIA AND CHRISTIAN SOCIAL PRACTICE: CHALLENGING CONTEXTS AND EMERGING TRENDS

The Tenth Conference for Research in Diaconia and Christian Social Practice

1-4 April 2025

Caring for one another is part of being human and has produced different of helping practices in different cultures. One form of helping that is salient for Christianised Western cultures can be seen in organisations where people can receive help in emergencies independently of family ties in the name of loving one's neighbour. These charities are named after the Greek word *diakonia*. Today's Christian diaconal welfare organisations mostly emerged in the 19th century to combat the social consequences of industrialisation in Europe. Christian missionaries spread the concept of *diaconia* to other parts of the world in the wake of colonialism. Thus, manifold traditions of Diaconia and Christian Social Practice have evolved worldwide that noticeably include the many Christian formations that have grown independently from the mainline Christian traditions (e.g., African Initiated Churches, Pentecostal-Charismatic Churches).

Against this background, this Call for Abstracts invites contributions from across the aforementioned wide spectrum of formations and traditions to advance a *global* debate on *diaconia* and Christian social practice. In view of meeting this aim, the call takes account of the fact that "diaconia" may not be the salient concept used in many contexts and that the notion of "Christian social practice" more appropriately incorporates and defines the practices of Christian social care, social welfare and social development prevalent in those contexts.

This call acknowledges and relates to recent encyclopaedic and other related work similarly aimed at advancing a global debate on Diaconia and Christian Social Practice: *International Handbook on Ecumenical Diaconia* (2021); *International Handbook on Creation Care and Eco-Diaconia* (2022); and *Diaconia and Christian Social Practice in a Global Perspective* (*Religions*, Special Issue 2023/24) (see full references below). Building on this recent scholarly work, the REDI Conference

Call 2025 seeks to further advance a global debate and perspective through paper contributions across a wide scope of thematic, topical and contextual possibilities.

The following topics/tracks serve as a guideline for paper contributions:

- 1. Diaconia and colonialism: Entanglement and detachment.
- 2. Diaconia of the marginalised: self-empowerment and self-representation through church-based initiatives towards social responsibility in local Christian social practices.
- 3. Diaconia, climate change, creation care and the sustainable development goals (SDG) agenda.
- 4. Expressions of Christian social practice (*diaconia*) in independent (including neo-Pentecostal and Charismatic) Christian traditions and churches / New approaches and practices of the diaconal church.
- 5. Diaconia and the non-profit sector: questions of diaconal agency and identity in market-related and civil society contexts.
- 6. Diaconia in dialogue with religion and development (RaD) / Diaconia and religion and development as overlapping expressions of Christian social practice.
- 7. Diaconia and interreligious or secular collaborations: Challenges and opportunities.
- 8. Conviviality, diaconia and society: transforming vision and creative practice for life together.
- 9. Health and healing in diaconal practice: Trauma healing, diaconal health, science, social healing and other practices.
- 10. Youth agency: Diaconia by, with and for the young people.
- 11. Diaconia and the *missio Dei*: New thoughts on the relationship between Diakonia and Missiology
- 12. Practitioners' research: Reflections on diaconal practice

Open Session: Miscellaneous Papers

Papers outside the above scope will be accommodated in separate sessions.
